### **Introduction**

The Campaign to Protect Rural England (Norfolk branch) uses information collected from supporters and visitors to this website to improve the information we offer to you and to improve your online experience. We take your privacy very seriously. This privacy policy sets out details of the personal information we collect about you and the ways in which we may use that information.

### **When do we collect personal information?**

We collect personal information from you when you complete a donation or contact form and when you enter any events or competitions on this website. You may also be asked whether you would like to participate in surveys about this website to help us improve our service. Whether you participate in these surveys or not will be up to you.

### **What may your personal information be used for?**

If you are a CPRE supporter, we may use the personal information to:

- Inform you of our work and the different ways in which you can help
- Ask you to support a specific CPRE activity
- Telephone you to ask for your support
- Share personal information supplied by you (except for any financial transaction information) with authorised third parties unless you have specifically denied
- consent for CPRE Norfolk to do so.

If you are a CPRE supporter or you provide us with personal information in the context of an event, we may use your personal information to:

- Assess and develop future CPRE Norfolk events and activities
- Inform you about other CPRE Norfolk events provided that you choose to receive this information

If you choose to receive information about the activities of other charities whose aims are similar to those of CPRE Norfolk, we will only disclose your information to those organisations who have assured us that they will not use your personal information for any purpose other than to provide this information to you. If after receiving information you decide that you no longer want your details held by that organisation, you should contact that organisation directly.

You should be aware that if you subsequently give any personal information to another company, the uses to which that information may be put will be determined by that company's privacy policy. For example where there are links to external websites and where you submit personal details using forms on that website, the privacy policy on that site will then apply.

If you are a CPRE supporter, you may at any time change your mind about receiving information from us. If you initially chose to receive such information, and subsequently decide that you no longer wish to receive information about either CPRE Norfolk or other organisations we may share your details with, you can notify us by email: [info@cprenorfolk.org.uk](mailto:info@cprenorfolk.org.uk)

### **Use of Cookies**

A "cookie" is a piece of information, like a tag, which some websites create on your PC. Our cookies allocate each user of this website with a random number.

This procedure does not entail the collection of any personal information. Our cookies will not be used to analyse your visits to other websites or track any internet searches you may undertake whilst on this website.
